Section 2 : **Product Composition (Classification)**

The subject formulation is a blend of carbohydrates, inorganic salts. Phenol red is included as a pH indicator After preparation in purified water, all ingredients are in concentrations of less than 1%.

Section 3 : **Hazards Identification**
